Economic, Social and Cultural Rights

All Zambians should have the right to clean water and appropriate sanitation, adequate health care and quality education.

The right to the common use of goods, according to John Paul II is the “first principle of the whole ethical and social order”

But, sadly, for many people, this is not the case:

- ◆ 33% of the population representing about 5.3 million people do not have access to safe water, while 56% representing 9.1 people in Zambia do not have access to adequate sanitation
- ◆ Long distances to health facilities remains a challenge
- ◆ Efficiency indicators reveal 1.5% drop out rate for primary schools education while secondary school drop out is at 1.2% indicating low completion rates for most pupils.

Principles of Catholic Social Teaching

The Social Doctrine of the Church helps to develop individuals through the community. It helps us become more fully human, and act as God’s instruments on earth.

Catholic Social Teaching also calls for a preferential option for the poor, we all need to ensure that all are included.

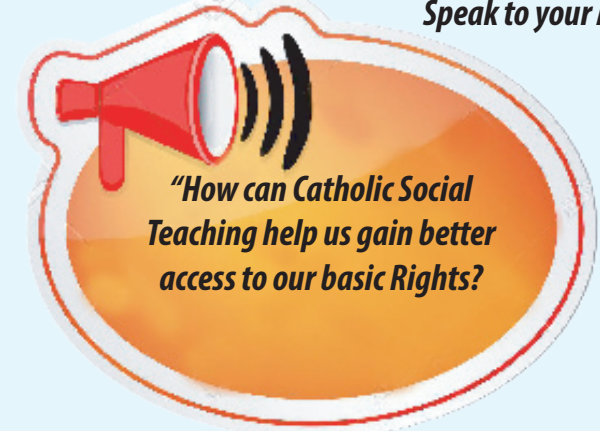
Catholic Social Teaching includes:

- ◆ Subsidiarity—decisions that affect people should be made by the people

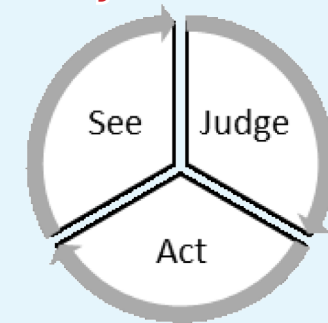
Preferential option for the poor requires that we work together so that all people get access to Catholic Social Teaching Action.
