## **BRIEF PROFILE**



Rev. Dr. Mwamba D. Mutale, S.J, is a Zambian Jesuit priest with a distinguished academic and professional background in economics. He holds a Ph.D. in Economics from Fordham University, New York, specialising in quantitative economics and applied econometrics. He also earned a Master's degree in Economics from Fordham University and a Bachelor's degree in Economics from the

University of Zambia. His research primarily focuses on the relationship between financial development and economic growth in emerging and developing economies. Additionally, he has explored critical topics such as debt, inequality, tax justice, and the economic burden of non-communicable diseases, including anaemia.

Fr. Mutale previously served in a managerial capacity at the Jesuit Centre for Theological Reflection (JCTR) in Lusaka, leading the Social and Economic Development Programme. Beyond his academic and professional pursuits, he has also served as an assistant pastor in Matero and Bwacha Parishes in Zambia, enriching his work with a pastoral perspective.

A native of Chingola, Fr. Mutale joined the Society of Jesus in 2007 in Lusaka. He earned a degree in Philosophy from the University of Zimbabwe in 2012 and subsequently worked at JCTR until 2014. He later obtained a Bachelor of Theology (Hons.) from the Catholic University of Eastern Africa in Nairobi in 2017. Fr. Mutale was ordained a priest in Lusaka in 2027.
